

Erasmus+ App Competition by ESN International

Terms & Conditions of the competition:

1. The promoters are the consortium members of the Erasmus+: Eötvös Loránd University (ELTE), Aristotle University of Thessaloniki, Erasmus Student Network (ESN), European University Foundation. And led by ESN AISBL whose registered office is at Rue Joseph II, 120, Brussels.
2. The competition is open to students who have participated (or are participating at the moment) in an Erasmus+ exchange program, aged 18 years or over except employees of ESN AISBL, their close relatives and anyone otherwise connected with the organization or judging of the competition.
3. Entry date for the contest will be 21/09/2021 and closing date for entry will be 21/04/2022. After this date no further entries to the competition will be permitted.
4. In order for a student to participate in the contest, they have to upload their Erasmus mobility tip from the Tips Section of the Erasmus+ App which can be downloaded via [Android](#), [Apple](#) or alternatively accessed [via PC](#).
5. No responsibility can be accepted for entries not received for whatever reason.
6. The promoter reserves the right to cancel or amend the competition and these terms and conditions without notice in any event outside of the promoter's control. Any changes to the competition will be notified to entrants as soon as possible by the promoter.
7. The promoter is not responsible for inaccurate prize details supplied to any entrant by any third party connected with this competition.
8. The prize is as follows: The prizes are as stated and no cash or other alternatives will be offered. The prizes are not transferable. Prizes are subject to availability and we reserve the right to substitute any prize with another of equivalent value without giving notice.

10. The winner will be notified by email within 28 days of the closing date. If the winner cannot be contacted or does not claim the prize within 7 days of notification, we reserve the right to withdraw the prize from the winner and pick a replacement winner.

 - g. You will be responsible for any claim made by any third party in respect of your entry and to fully indemnify ESN AISBL and its sponsors in respect of all royalties, fees and any other monies owing to any person or entity by reason of your breaching any of the foregoing.

Any personal data relating to the winner or any other entrants will be used solely in accordance with current European data protection legislation and will not be disclosed to a third party without the entrant's prior consent.
