

## **Competition Terms & Conditions**

- 1. **INTRODUCTION**: Erasmus Student Network AISBL, Rue Joseph II 120, 1000 Brussels, Belgium (hereinafter "ESN") is organising the competition **Share your Erasmus travel story**, hereinafter "the Competition", as described by these Terms and Conditions
- 2. **ELIGIBILITY**: The Competition is open to members of any ESN section that have obtained the legal age, hereinafter "the Participant(s)"
- 3. **TIMING**: The Competition is open from September 23<sub>rd</sub> until September 30<sub>th</sub> 23:59.
- 4. **RULES OF THE COMPETITION**: a. Participants shall fully fill in the form at https://esn.org/share-your-erasmus-travel-story
- 5. WINNER NOTIFICATION: a. The answer to the question SHARE YOUR ERASMUS TRAVEL STORY.

At the end of the Competition Period, 4 winners will be selected among all eligible Participants received to win a prize based on the following criteria:

At the end of the competition, Ryanair social media team will contact all 4 winners of the competition and will schedule with them a video recording in the city of their residence or the closest Ryanair airport.

**6. PRIZE:** All 4 winners will receive 25 EUR voucher for Ryanair flight. All 4 winner will take part in Ryanair's campaign with the theme of Erasmus travel stories.

## 7. PARTICIPATION CONDITIONS:

Participants accept that:

- a. The participation in the Competition must be fully completed and in accordance with the Competition's Terms and Conditions.
- b. ESN's decisions as to the administration and operation of the Competition and the selection of the potential winner is final and binding in all matters related to the Competition and is not open for discussion with ESN.
- c. At the time of participation, Participants are deemed to have read, understood, and be in agreement with the Terms and Conditions of the Competition. Should they not agree with





the Terms and Conditions, they shall not proceed with the Competition. By continuing to participate in this Competition, they agree to be bound by these Terms and Conditions.

d. ESN retains the right to exclude Participants from participating in the Competition and to delete participations if these are not compliant with these Terms and Conditions.

- 8. **DATA PRIVACY POLICY:** The personal data processed for the requirements of the Competition are declared to the Privacy Protection Commission in accordance with the Law of 8 December 1992 on privacy protection with regard to the processing of personal data. The Participants are advised that their personal data collected under the Competition are necessary to process their participation. This data is intended exclusively for ESN and its subcontractors and service providers for Competition management requirements. ESN may ask Participants to give their express consent to receiving of information on ESN and promotional operations by email. The Participants may exercise their right to access, rectify, or challenge the data concerning them in writing to the address of ESN.
- 9. **AGREEMENT:** By entering the Competition the Participants agree to abide by all rules.
